Events, including but not limited to the Kentucky Derby Festival, Inc.; The Fillies, Inc.; all Presenting & Contributing Sponsors, all vendors providing service at Kentucky Derby Festival Events and for the Royal Court Program; their agents, successors, representatives and assigns even though that liability may arise out of negligence or carelessness on the part of the persons named in the waiver.

I assume the risk of all bodily injuries including death, resulting therefrom and personal injuries to me and damage to and loss of my property, including loss of use thereof and any other indirect or consequential damages, resulting directly or indirectly, wholly or in part, from my participation as a Kentucky Derby Festival Princess in the Royal Court Program during or after any Kentucky Derby Festival or The Fillies, Inc., Events and while traveling to and from the Events.
